PLACING ORDERS: All orders are considered firm and final at the time of placement. Any additions or changes will be entered as a new order or addition and an updated order acknowledgement will be issued. We require a Sales Tax Exemption Certificate to be on file or considered for exempt status prior to shipment of your first order.

PURCHASE ORDER REQUIREMENTS: In order to prevent production delays, please be sure to include all of the details listed here:

- 4) If applicable, advise the method of all art & specs

ARTWORK: If applicable, submit vector art with clear, concise instructions. Art provided in any format other than vector files may require additional charges and delay production. Artwork charges are \$90.00 per hour. Exact duplication of logos and type styles cannot be guaranteed unless vector art is sized to specifications. Unless otherwise requested, Onni Creative will size art to best fit the area. Artwork submitted via e-mail must meet the following specifications: files should be in vector format or a PDF from Adobe Illustrator (.ai). If there are any images used, they should be no less than 300 dpi, with outlined text. Send artwork (as attachments) to your Onni Creative representative with your PO number in the subject line.

PRODUCTION TIME: Production time for each project begins after signed artwork proof and/or purchase order is approved. Production time does not start the day the order is received. Seller is not responsible for non-fulfillment due to but not limited to: weather, strikes, fire, and inability to obtain raw materials, customs clearance delays or other causes beyond our control. Seller is not liable for consequential or special damages due to any delay, even if seller was previously advised of the possibility of such damage.

OVER/UNDER PRODUCTION RUNS: All orders are subject to 10% over/under run. Billed accordingly.

PRICES: All prices are firm and are subject to change without notice.

CHANGES: Once approved artwork has been submitted and prepared, any design change or cancellation will result in the billing of any costs incurred.

ORDER CANCELLATIONS: All orders are considered firm and cannot be canceled except upon written permission and accepted in writing by Onni Creative. Changes or cancellation cannot be made once order has gone into production. Once in production, any requested changes will be billed, plus any additional work required by the change. If a change in quantity is made after the completion of any portion of production, the change will be treated as a separate order and billed accordingly. Any change made after the start of production will delay shipping. If a cancellation is necessary and approved by Onni Creative, all costs associated with work performed to date of cancellation will be invoiced, including a minimum of \$75.00 cancellation fee. Cancellation must be in writing and acknowledged by Onni Creative.

NO CANCELLATIONS ALLOWED ON RUSH ORDERS.

Shipping or address changes must be made 72 hours in advance of ship date. A \$50.00 charge will apply.

ORDER ACCEPTANCE LEVELS: Some products, including custom manufactured may include slight variances in the size of the finished product.
